**AMENDED GENERAL ORDER 33  
(Effective February 1, 2023)**

**Prior Version Superseded**

The prior version of General Order 33 (effective from July 1, 2017) is hereby superseded and modified by this *Amended General Order 33*, as follows:

**Del Norte and Humboldt Counties  
(Eureka Cases - All Cases)**

All bankruptcy cases filed on or after July 1, 2017 and venued in Del Norte County or Humboldt County, and any adversary proceeding associated with such a bankruptcy case, shall continue to receive a Santa Rosa Division<sup>1</sup> case number and be assigned to a judge in the Oakland Division.

**Napa, Sonoma, Mendocino and Lake Counties  
(Chapter 12 and Chapter 13)**

Chapter 12 and 13 bankruptcy cases filed on or after July 1, 2017 and venued in Napa County, Sonoma County, Mendocino County or Lake County, and any adversary proceeding associated with such a bankruptcy case, shall continue to receive a Santa Rosa Division case number and be assigned to a judge in the San Francisco Division.

**Napa, Sonoma, Mendocino and Lake Counties  
(Chapters 7, 9, 11 and 15)**

Chapter 7, 9, 11 and 15 bankruptcy cases filed on or after February 1, 2023 and venued in Napa County, Sonoma County, Mendocino County or Lake County, and any adversary

The Santa Rosa Division presently consists of Del Norte, Mendocino, Humboldt, Napa, Sonoma, and Lake counties. B.L.R. 1001-3(a). Venue is determined as consistent with 28 U.S.C. §1408 and §1410.


1 proceeding associated with such a bankruptcy case, shall continue to receive a Santa Rosa  
2 Division case number and shall receive an assignment to a judge of the Oakland Division.

3 **Abrogation of General Order 27 and Marin County Cases**  
4 **(All Cases)**

5 All bankruptcy cases filed on or after July 1, 2017 and venued in Marin County, and any  
6 adversary proceeding associated with such a bankruptcy case, shall continue to receive a **San**  
7 **Francisco Division** case number and be assigned to a judge in the San Francisco Division.<sup>2</sup>
