For purposes of Judge Blumenstiel's calendar, Contested Matters will not include: Motions filed in cases under any chapter of the Bankruptcy Code for relief from the Automatic Stay, to extend the Automatic Stay, or to seek a determination as to whether the Automatic Stay applies; or any motion not pertaining to the Automatic Stay filed in a case pending under Ch. 13 of the Bankruptcy Code.

Motions pertaining to the Automatic Stay will be heard on the dates referenced in Part B below. Motions in Ch. 13 bankruptcy cases will be heard on the dates referenced in Part C below.
