This *Order* sets forth the reassignment of pending bankruptcy cases and adversary proceedings currently assigned to Judge Charles Novack, effective May 15, 2026.

Accordingly, it is ordered that:

1) With the exception of the cases listed in paragraphs 2 and 3 of this *Order*, all bankruptcy cases pending as of May 15, 2026 and assigned to Judge Charles Novack shall be reassigned to the following judges of this Court based on the last digit of the bankruptcy case number:

Judge William J. Lafferty: 1, 2 and 3 as stated on the attached **Exhibit A**.

Judge Dennis Montali: 4, 5 and 6 as stated on attached **Exhibit B**.

Judge Hannah L. Blumenstiel: 7, 8, 9 and 0 as stated on the attached **Exhibit C**.

Any adversary proceeding associated with a reassigned bankruptcy case is reassigned to the judge responsible for the main bankruptcy case.

2) *In re The Roman Catholic Bishop of Santa Rosa*, Chapter 11, Case Number 23-10113, and any adversary proceeding associated with Case Number 23-10113, shall be reassigned to Judge William J. Lafferty (listed on **Exhibit A**).

3) *In re LeFever Mattson*, Chapter 11, Case Number 24-10545, all bankruptcy cases jointly administered or consolidated with *LeFever Mattson*, and adversary proceedings associated with *LeFever Mattson* or associated with such a jointly administered or consolidated case, shall be reassigned to Judge Hannah L. Blumenstiel (listed on **Exhibit C**).
