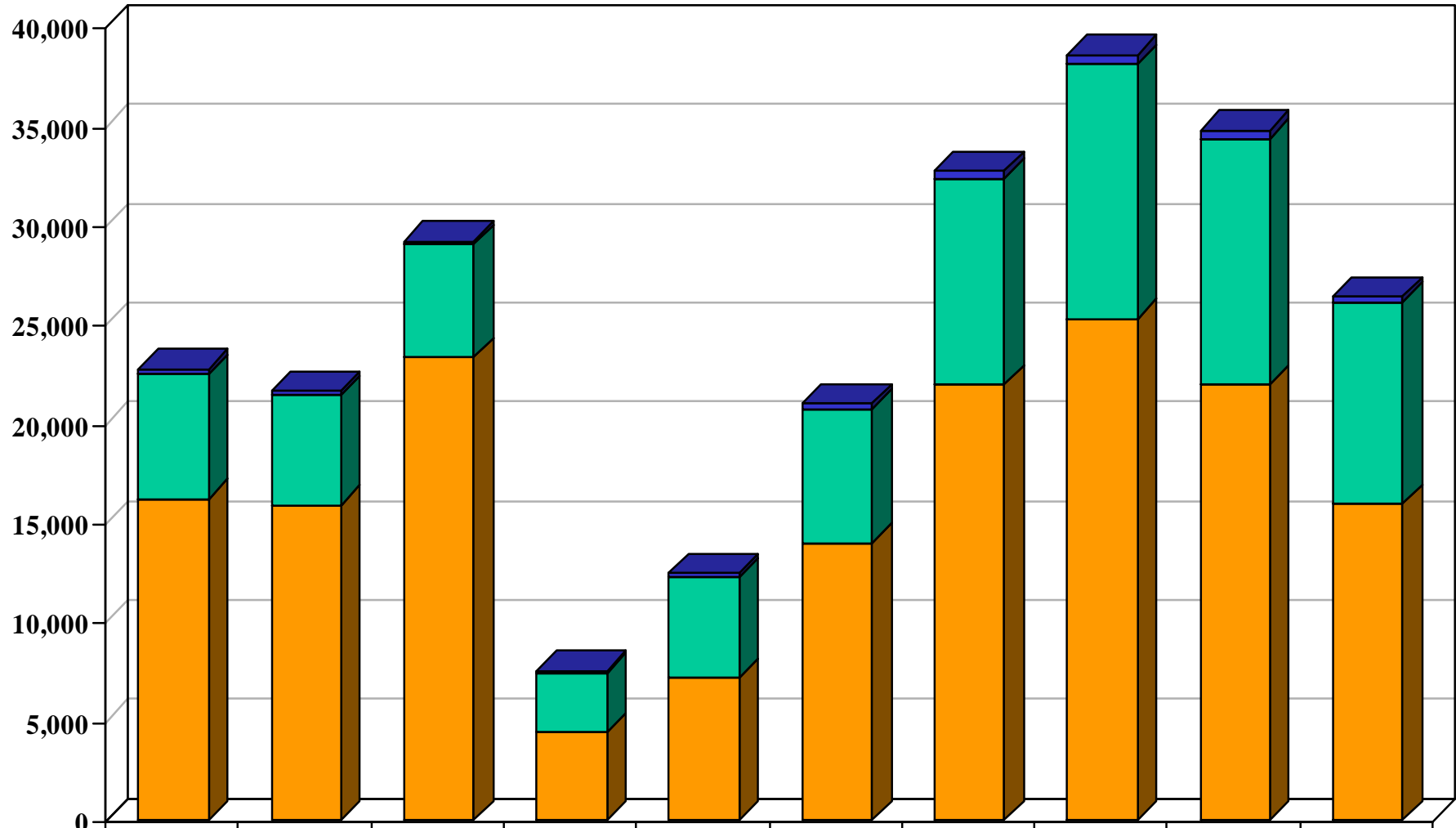


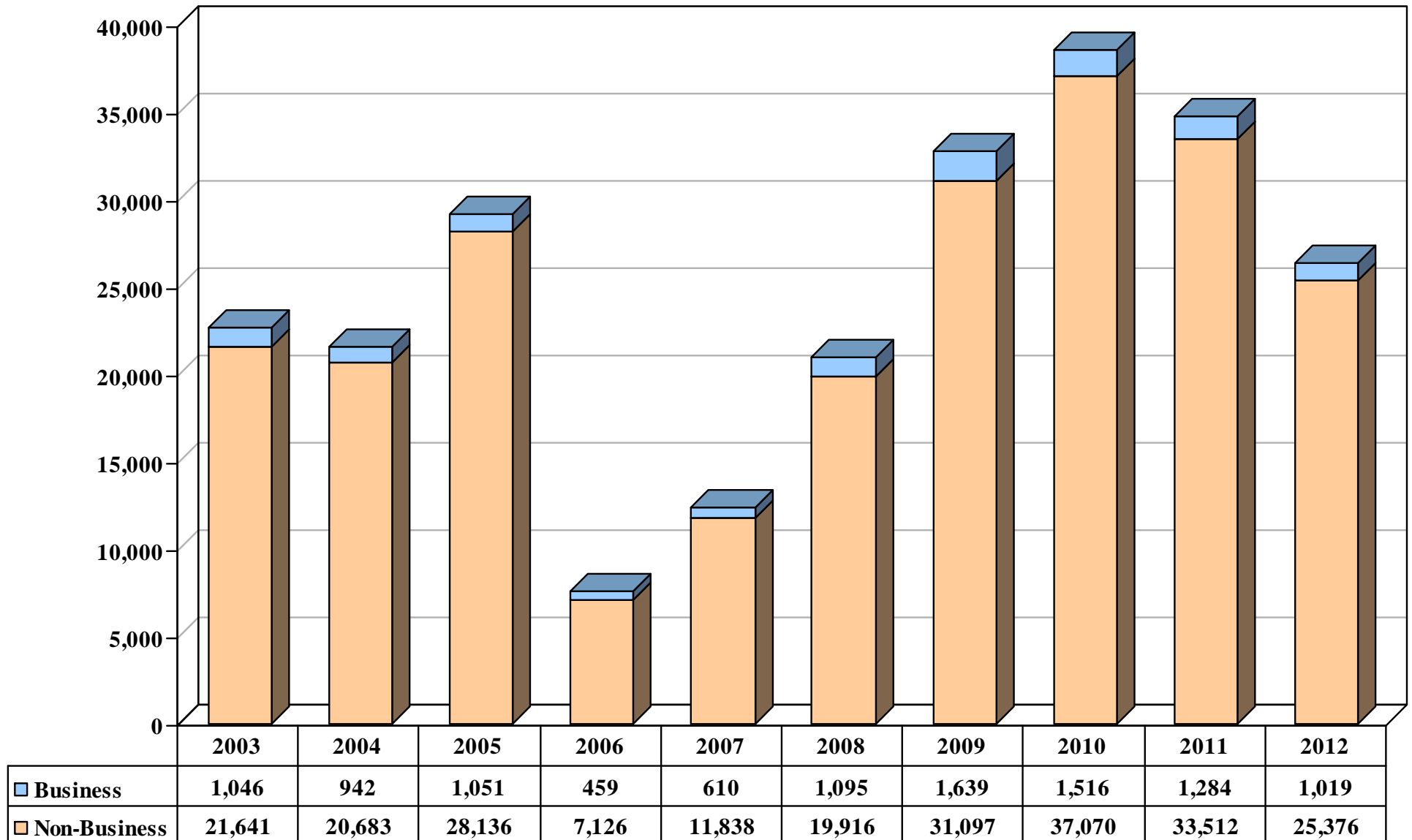

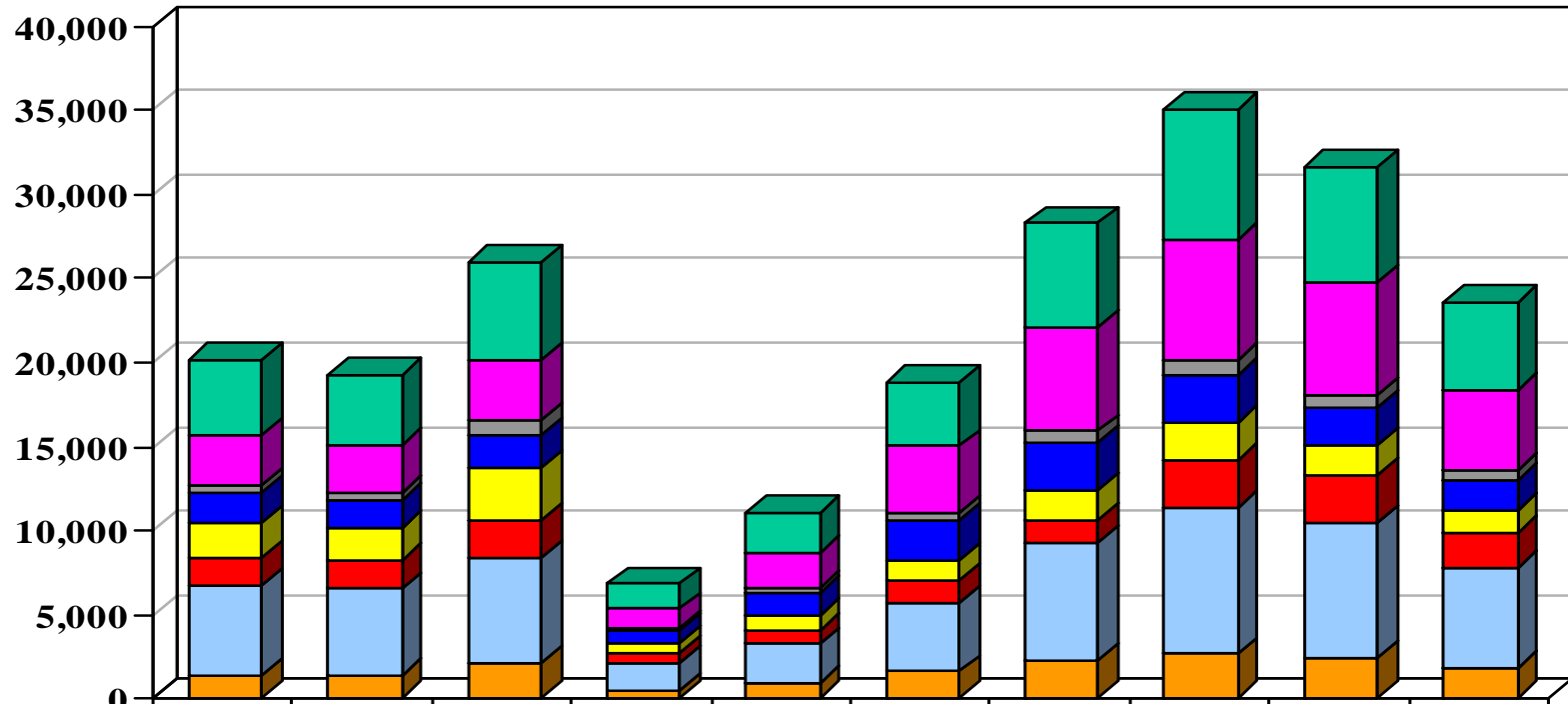
# Northern District of California - Bankruptcy Case Filings by Type Ten Year Period 2003 - 2012

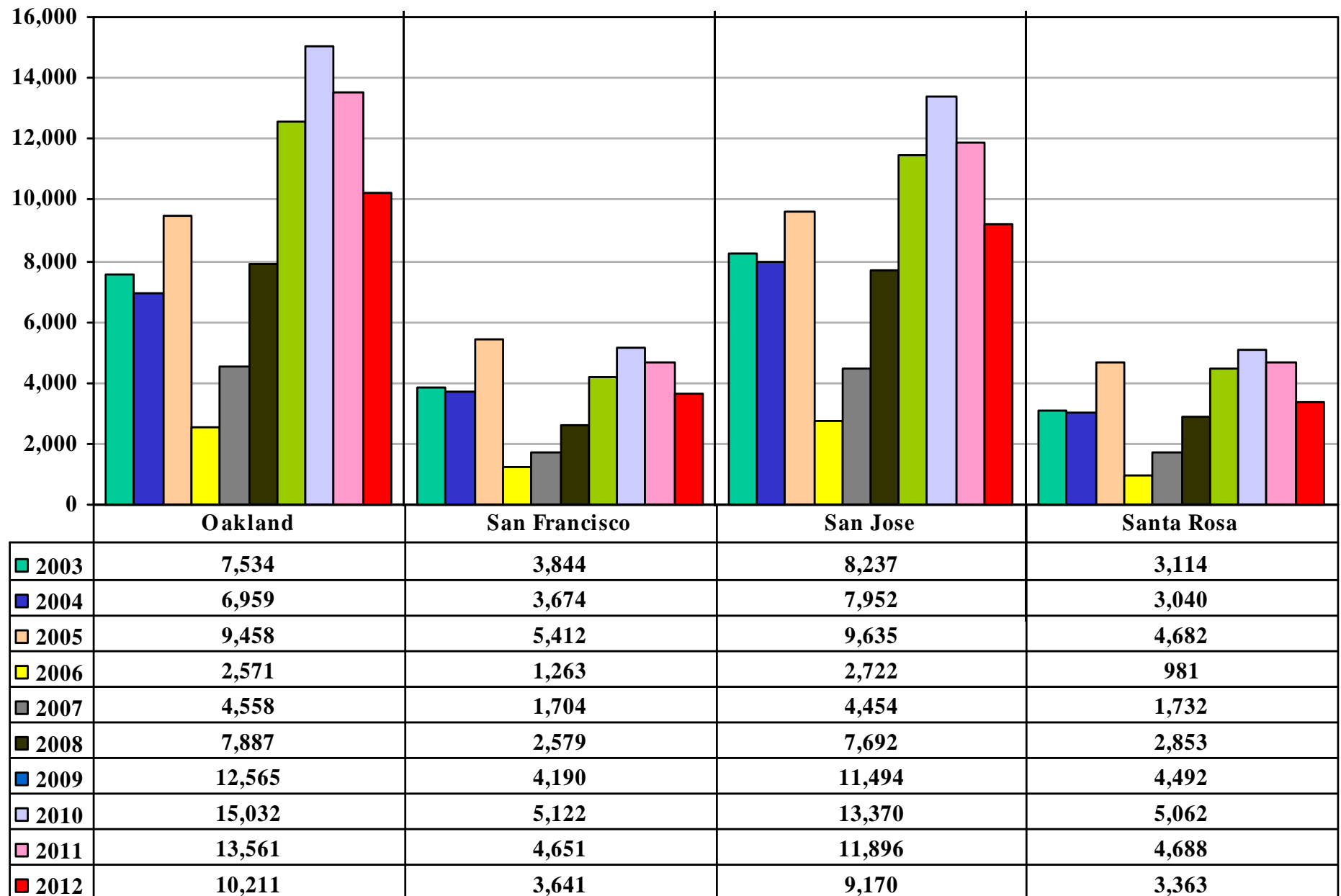

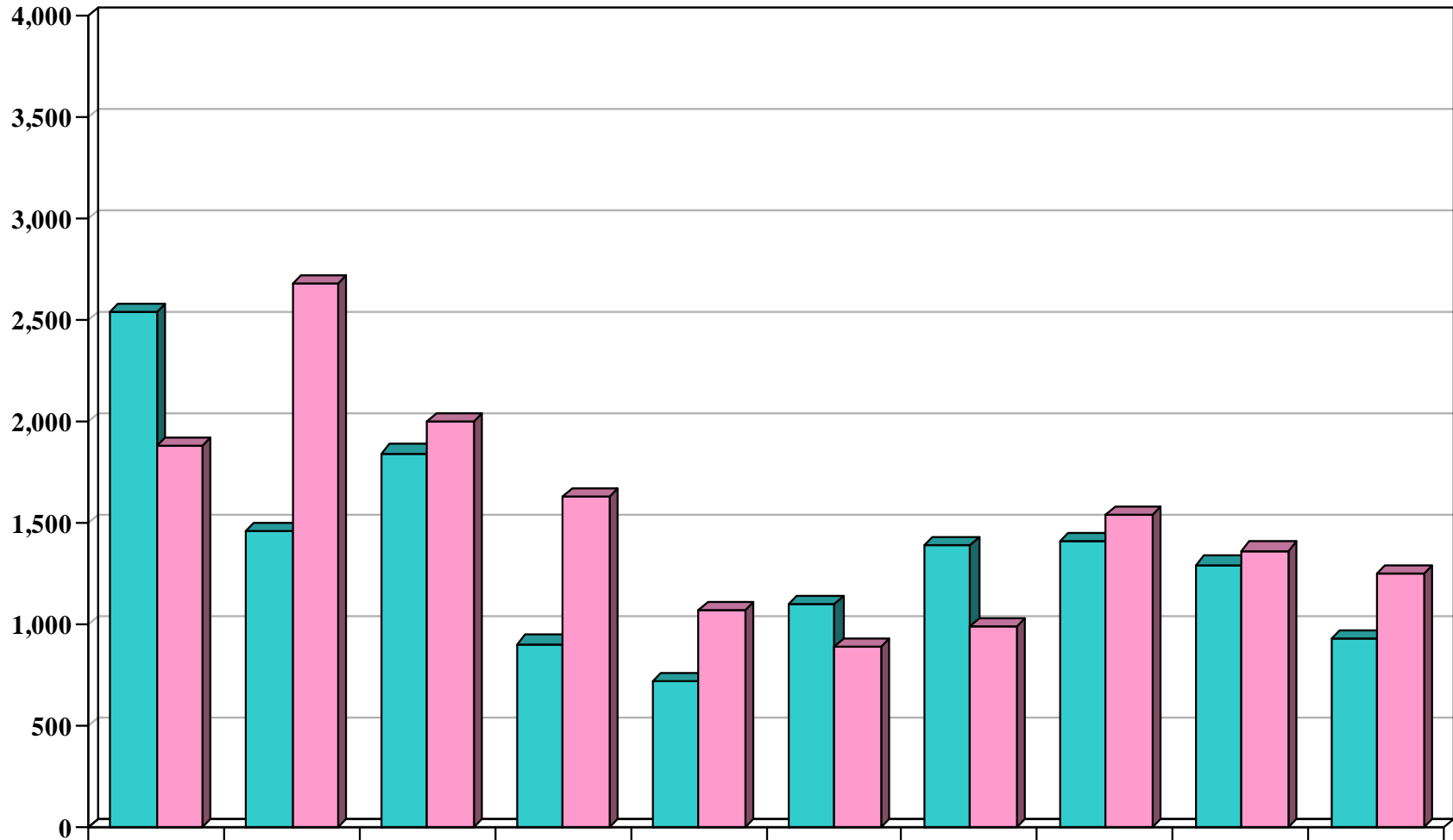

# Northern District of California - Bankruptcy Case Filings by Division Ten Year Period 2003 - 2012



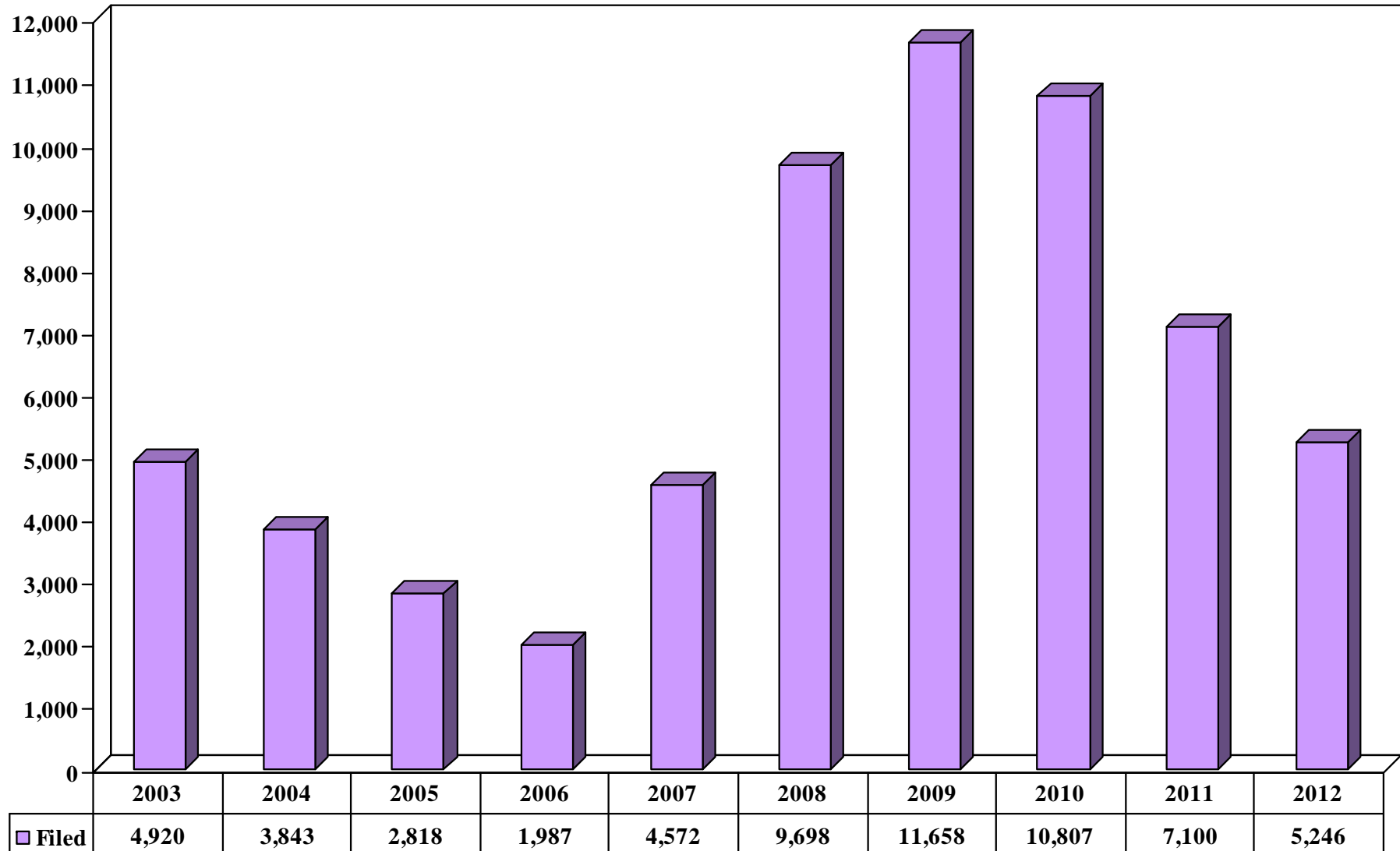

## Northern District of California - Adversary Proceedings Ten Year Period 2003 - 2012

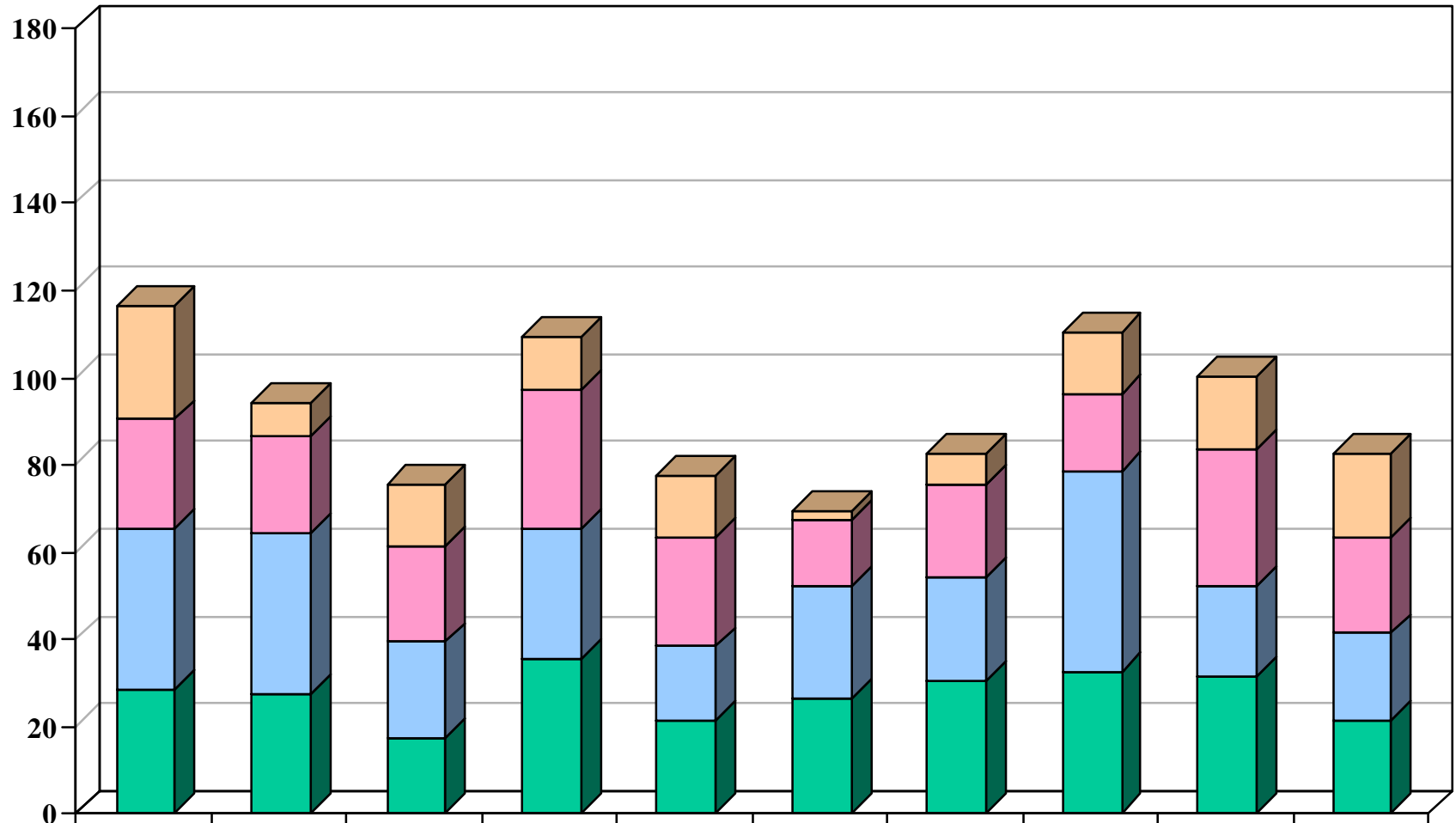
