

## **United States Bankruptcy Court Northern District of California**

### **Access to Courthouse and Clerk's Office for Persons with Disabilities**

#### **San Francisco**

The San Francisco Division of the United States Bankruptcy Court and Clerk's Office, located in the Phillip Burton Federal Building and United States Courthouse at 450 Golden Gate Avenue, is wheelchair-accessible from the Golden Gate Avenue and Turk Street entrances. Automatic doors are available at both entrances. Six public elevators provide access to floors housing the Clerk's Office and courtrooms. The Clerk's Office intake counter, all courtrooms, and all publicly-accessible restrooms on floors housing courtrooms and the Clerk's Office accommodate wheelchair access. Vehicle parking designated for persons with disabilities is available at all major parking establishments surrounding 450 Golden Gate Avenue.

#### **Oakland**

The Oakland Division of the United States Bankruptcy Court and Clerk's Office, located in the Oakland City Center at 1300 Clay Street, is wheelchair-accessible from the Clay Street and City Center entrances. An automatic door is available at the Clay Street entrance. Four public elevators provide access to floors housing courtrooms and the Clerk's Office. The Clerk's Office intake counter, all courtrooms, and all publicly-accessible restrooms on floors housing courtrooms and the Clerk's Office accommodate wheelchair access. Vehicle parking designated for persons with disabilities is available on Clay Street, within the City Center complex garages, and at parking establishments surrounding 1300 Clay Street.

#### **San Jose (Salinas)**

The San Jose Division of the United State Bankruptcy Court and Clerk's Office, located in the Robert F. Peckham Federal Building at 280 South First Street, is wheelchair-accessible via street-level access on the First Street side, and by two ramps on the Second Street side. Three public elevators provide access to the upper floors. The Clerk's Office intake counter, all courtrooms, and all publicly-accessible restrooms on floors housing courtrooms and the Clerk's Office accommodate wheelchair access. Surrounding 280 South First Street, vehicle parking designated for persons with disabilities is available at parking establishments, and general parking on public streets is also available.

Periodically, the San Jose Division holds court hearings in Salinas. The Salinas courthouse, located at 1000 South Main Street, is wheelchair-accessible via the street level entrance opposite South Main Street. The courtroom and restrooms on the ground floor are wheel-chair accessible. Vehicle parking is available at parking establishments and on public streets surrounding 1000 South Main Street.

#### **Santa Rosa (McKinleyville)**

The Santa Rosa Division of the United States Bankruptcy Court and Clerk's Office, located at 99 South "E" Street, is wheelchair accessible via the main entrance facing "E" Street. The Clerk's Office intake counter, all courtrooms and publicly-accessible

restrooms on floors housing courtrooms and the Clerk's Office, accommodate wheelchair access. Vehicle parking designated for persons with disabilities is available fronting and adjacent to the building, at nearby parking establishments, and general parking is also available on public streets surrounding 99 South "E" Street.

Periodically, the Santa Rosa Division holds court hearings in McKinleyville. The entrance to the McKinleyville United States Courthouse, located at 3140 Boeing Avenue, is wheelchair-accessible via a front ground level entrance. The courtroom facilities and restrooms on the ground floor are wheelchair-accessible. Vehicle parking designated for persons with disabilities is available in front of the building.
