## Procedures for Appearing on an AT&T Conference Call for the Honorable Stephen L. Johnson

- Persons appearing will be authorized by the courtroom deputy to **speak only on the matter they are assigned to.**

Persons requesting **continuances** should notify the courtroom deputy by email in advance of the hearing, otherwise matters will be called in order.

Please ensure your **equipment** is adequate. Also, ensure that you have dedicated, **quiet space** for the call. Do not conduct other conversations while on the call even if you are muted.

Reservations <u>not</u> required.

- 1. Select "As Guest"
- 2. Enter (888) 363-4735 in the Dial-in phone number
- 3. Meeting access code: 4426317
- 4. Enter your first and last name and case name
- 5. Check the box "I'm not a robot" and follow the prompt
- 6. Click on the "**Call me**" button. You will be prompted to add your dial-out number. AT&T will dial out to the number you provided.
- 7. When prompted, select #1 to join the conference
